6. Description and Justification of Project:

BACKGROUND:

Foot and Mouth Disease (FMD) and Peste des Petits Ruminants (PPR) are the major Trans-boundary Animal Diseases that are most prevalent and economically the most important infectious diseases of livestock in Pakistan. FMD is endemic in the country and

as well in Khyber Pakhtunkhwa Province with occurrence of outbreaks throughout the year. The disease severely affects milk production in addition to mortality in calves and loss of body condition and draught power. Similarly PPR is considered as one of the fatal disease of small ruminants (sheep & Goats) resulting in huge mortality rates and economical losses, it is estimated that National economic losses due to PPR is more than PKR 50.200 billion annually. Thus the diseases threaten food security and the livelihoods of smallholders and prevents animal husbandry sector from developing its economic potential. Apart from the economic losses both the diseases serve as major barrier for international trade of livestock and livestock products. World Trade Organization (WTO) through SPS Agreement provides a legal framework for safe international trade. Pakistan being WTO member is legally bound to follow the obligations under WTO-SPS Agreement for import and export of animal products. Moreover, the agreement recognizes World Animal Health Organization (OIE) as International standard setting organization which means following OIE Standards compliance with WTO Obligations.

OIE has set international standards to gain recognition of a disease free country or area. In past few years a series of projects at National level with the assistance of FAO were launched towards progressive control of FMD and PPR in Pakistan, with some remarkable achievement but to gain a disease free status for the country does not seem an easy task in near future.

Fortunately, for a country having endemic status of a disease, WTO-SPS Agreement came up with the concept of disease free zone following OIE international standards for recognition.

OIE-Listed diseases, infections and infestations in force in 2019

Resolutions passed by the International Committee and recommendations issued by the Regional Commissions instructed the OIE Headquarters to establish a single OIE list of notifiable terrestrial and aquatic animal diseases.

The list is reviewed on a regular basis and in case of modifications adopted by the World Assembly of Delegates at its annual General Session, the new list comes into force on 1 January of the following year.

For year 2019, the list includes 117 animal diseases, infections and intestations out of which the two most important diseases which are important economically, trade wise and in term of mortality and outbreak spread wise. These two diseases are more prevalent in

district Kurram and due to its prevalence the diseases are taken to be controlled and free the district with in few years as per OIE guidelines.

Keeping in view, the proposed project was included in annual Development Plan of the Government of Khyber Pakhtunkhwa (Merged Areas) with the objective to minimize the trade barriers by establishing disease free zone in the province.

Situation Analysis:

In tribal district Kurram, the department of L&DD has established 4 Civil Veterinary

Hospitals, 24 Civil Veterinary Dispensaries, 25 Civil Veterinary Centers and 22 Artificial
Insemination Centers. Besides one mini Veterinary Diagnostic Laboratory and two
Mobile Veterinary Clinics are operational in the district. The Detail is below:
